The right to erasure — You have the right to request that Excel Voice & Data Limited erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Excel Voice & Data Limited restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Excel Voice & Data Limited's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Excel Voice & Data Limited transfer the data that we have collected to another organization, or directly to you, under certain conditions.

There are several different types of cookies, however, our website uses:
